# CONTRACT

Alabama Waldorf School (AWS) will invoice the undersigned through TADS the sum of \$41 for payment of the **non refundable** registration fee. In consideration of the acceptance of the enrollment of the above child by Alabama Waldorf School, the undersigned agree(s) to remit tuition for the Summer Program in accordance with provisions of this agreement.

**Please initial one of the following to indicate your choice of payment options:**

\_\_\_\_\_ **Option A:** Pay summer tuition in full by June 10 or July 10, 2023.

\_\_\_\_\_ **Option B:** Pay summer tuition in 2 equal monthly payments: June 15 and July 15, 2023

AWS will bill through TADS invoices on June 15 and July 15, 2023. If a tuition payment is not received by the 22nd of the month, Alabama Waldorf School will charge the undersigned a late fee of \$40 and may require the undersigned to provide credit card or bank draft information. After a second late or missed payment, the monthly amount owed will automatically be charged by credit card or bank draft for the remainder of the summer, using the information provided.

Under all Options, if any payment is returned due to insufficient funds, Alabama Waldorf School may also charge a fee of \$40 per occurrence in addition to any other fees. Alabama Waldorf School may also suspend the enrollment of a child for whom tuition is not paid according to the terms of this contract, and/or declare the balance of the full tuition herein provided immediately due and payable. The procedure for addressing late or delinquent accounts may be reviewed in the school office by any parent, guardian, or other individual responsible for payment of the child's tuition and fees. Failure to pay tuition is a material default of the terms of this contract and is basis for legal action. In the event of default, then the undersigned agree(s) to pay all costs of collection including reasonable attorney's fees as determined by the court as well as court costs and interest at the highest rate permitted by the State of Alabama but not to exceed fifteen percent (15%).

The enrollment of the child shall be subject to all rules and regulations established by the Faculty and Board of Trustees of Alabama Waldorf School, including but not limited to, the Parent Handbook and the Policy and Procedure Manual. This agreement may be terminated by the undersigned upon 7 days written notice to Alabama Waldorf School in the event the undersigned is (are) required to leave the Birmingham metropolitan area due to a permanent change or transfer of employment. This agreement shall be automatically terminated in the event of death of such child or injury or illness which, in the opinion of the attending physician conveyed in writing to the school, would prevent the attendance of such child at the above-described program for the remainder of the school year.

**If the parent/guardian, for any reason other than those listed herein, terminates the contract after the start of the summer program, the parent/guardian agrees to pay a \$100 cancellation fee. Because we are offering weekly enrollment options, changes to this contract do not guarantee a space and may result in an administrative change fee of \$25.**

This contract may be terminated by Alabama Waldorf School at any time and for any reason by giving written notice of termination or by giving verbal notice to the undersigned in the case of emergency circumstances. In no such event, however, shall Alabama Waldorf School be required to refund any tuition or fees previously paid.

Upon acceptance by Alabama Waldorf School, this shall become a binding contract between the parties hereto. The undersigned understand(s) and agree(s) that the commitments for personnel and other expenses are made by Alabama Waldorf School in advance for the full summer term, and that the obligation of the undersigned for the payment of tuition is for the summer term unless the contract is terminated as provided herein. This contract shall be governed by the laws of the State of Alabama, and in the event that any portion of this contract is declared null and void, the remaining portions shall remain in full force and effect. In addition, a decision by Alabama Waldorf School not to enforce any provision herein on one or more occasions shall not constitute a waiver on subsequent occasions.

Participant(s) waive, release and forever discharge all claims against Alabama Waldorf School and its employees for any injuries, damages, losses or claims, whether known and/or unknown which arise during, or result from, any activity or services provided by AWS in connection with enrollment in the summer program.

All parents, guardians, or other persons responsible for payments should read the provisions of this contract, complete the required information, sign, and return the contract to Alabama Waldorf School accompanied by the non-refundable registration fee. A student is accepted for enrollment or reenrollment only when the contract has been delivered to Alabama Waldorf School, signed and dated, and accompanied by all appropriate fees and forms.

**AWS Summer Preschool Program runs June 5 – July 28, 2023.**

**\*Please note that AWS will be closed on June 20 & July 3 - 4, 2023.**

**Open to currently enrolled AWS Nursery & Kindergarten students. \*\* Rising 1st graders are not eligible for this program.\*\***

Programs follow the Waldorf Early Childhood Curriculum and classroom rhythms. Please pack a lunch for your child. Rising Kindergartners will attend the Kindergarten Summer Program.

### **PAYMENT**

All billing, including the \$41 registration fee, will be invoiced through TADS. Summer tuition is invoiced as a separate line item from school-year tuition. If you have selected the 12-month school-year tuition payment plan in your TADS account, you will receive two charges in June and July, one for 2023-24 tuition payment and one for summer 2023 program tuition.

**Registrations are due by Thursday 12:30 pm the week prior to the week enrolled.**

**Whole Summer 5-day Discount:** 10% off the cost of the **Full Day** 8 am – 5:30 pm, M-F.

**FINE PRINT:** Contract cancellations prior to May 22, 2023 incur a \$75 fee. Contract cancellations after May 22 incur a \$200 fee. Changes to contract may incur a change fee of \$25. Space is not guaranteed until confirmed. You will be contacted by April 3 if there is no room in a program on a day you have selected. If you wish to sign up for additional time (on a space-available basis), during the summer, you must turn in paperwork to the office by the Thursday (12:30 pm) preceding the week your child plans to attend. **Signing up after the weekly deadline incurs a \$60 per day Emergency Drop-In Rate.** Read your contract for terms of payment.

**PLEASE NOTE: There will be no childcare available May 26 – June 5 and July 31 – August 15.**

The 2023-24 school session begins on August 16, 2023.
